#### STOGUMBER WOODLAND PROJECT

- 31.49 acres of land in West Somerset near the village of Stogumber
- 14.38 acres of woodland
- 17.11 acres of open land/arable/pasture
- Overall, it comprises mature woodland and recently planted (20 years ago) younger woodland.
   There is a small stream running through the site
- The primary purpose of this purchase is for carbon sequestration
- It is intended that Viper and its staff to act as custodians for the existing woodland and to work
  with the Woodland Trust and Forestry Commission to plant the majority of the remaining 17
  acres with woodland. There is also the opportunity for an element of re-wilding with some of the
  pasture land.
- It is also proposed that some of the land will be used for forestry research to compare the
  efficiency of planting versus natural colonization

### STOGUMBER – ACTIVITY SINCE PURCHASE COMPLETED

#### Stogumber

- Staff committee formed comprising representatives from Portishead & Aberdeen
- Entrance to site created to allow better access and parking
- Bureaucracy is delaying progress with woodland design (rural land register issue)
- A scoping study has commenced to design a wooden building. Planning permission will be sought for the build of this and the creation of a pond
- Staff and families will soon be asked to help with the site cleanup
